Mr. Rosenfield:

Your application requesting classification and registration of *High Power Rocket Motors* and reload kits to determine their compliance with California State Fire Marshal Regulations has been completed with the following results provided:

All rockets and reload kits that have been classified and registered by the State Fire Marshal shall be properly labeled and bear a printed California State Fire Marshal seal and the registration number of the licensee as required by California Code of Regulations Title 19, Article 7.

Please note that although devices may be classified and registered, no person shall import/export into or from California or sell high power rockets or motors unless they possess a valid import/export and wholesale license issued by the State Fire Marshal.
